## 2022 NASSC SPONSOR-VENDOR AGREEMENT & INDEMNITY

This agreement between the Hampton Roads Soccer Council and the North American Sand Soccer Championships, NASSC”, Virginia Beach, Virginia and the Sponsor, \_\_\_\_\_, herein referred to as “Vendor”, states as follows:

### **The Vendor agrees:**

- To pay all fees in accordance with the sponsorship contract completed with NASSC.
- If accepted into the NASSC as a vendor, Vendor must provide by Wednesday, May 4, 2022, a certificate of insurance indicating the Vendor is insured with a minimum \$1,000,000 public liability and comprehensive general liability policy, including product liability. The Hampton Roads Soccer Council as well as the City of Virginia Beach must be named as additional insureds for June 9-12, 2022. *See Vendor Information for exact names & addresses to be included.*
- To abide by all Virginia Beach City ordinances and NASSC vendor rules.
- To obtain all permits and licenses required by the City of Virginia Beach, including health permit and any other required forms.
- That all purchases of food and supplies are the responsibility of the Vendor. Ice will be available on-site for purchase.
- To use felt roofing paper on the entire ground area (sand/platform or boardwalk) of any food vending operation.
- If using cooking equipment, the Vendor shall comply with all City platform requirements.
- To attend the mandatory food vendor meeting (if applicable) at 11 am on Friday, June 10, 2022 at the Ramada Plaza on Atlantic Ave and 28th Street.
- To be set up and ready for Health Department Inspection (if applicable) by 1 pm on Friday, June 10, 2022. Failure to comply may result in prohibiting Vendor from being invited to subsequent tournaments.
- To abide by all policies set forth by NASSC and City of Virginia Beach regarding parking, load-in, and egress.

### **The North American Sand Soccer Championships will:**

- Provide Vendor with dedicated space within the event site
- Provide Vendor with electrical/water service for operation of concession equipment requested within the vendor application. Utilities will be provided only for equipment listed. NASSC and the City of Virginia Beach are not liable for connections to equipment that is not listed.
- Provide all food vendors cooking oil disposal containers and/or gray water disposal containers, within one block of their location if requested in Vendor application.
- NASSC assumes no responsibility for loss, theft, or damage of property belonging to the Vendor.

**Vendor Indemnity**

During the term of this agreement, the company and contact person listed below shall indemnify, hold free and harmless, assume legal liability for and defend Hampton Roads Soccer Council, t/a North American Sand Soccer Championships "NASSC", its agents, servants, employees, officers, and directors from any and all costs and expenses including, but not limited to, attorneys' fees, reasonable investigative and discovery costs, court costs, and all other sums which Hampton Roads Soccer Council t/a North American Sand Soccer Championships, its agents, servants, employees, officers, and directors may pay or become obligated to pay on account of any, all, and every demand or claim or assertion of liability or any claim or action founded thereon arising or alleged to have arisen out of Vendor's performance of this agreement or the operation of seller's/sponsor's/ vendor's business or any act or omission of Vendor, his agents, servants or employees whether such claim or claims, action or actions, be for damages, injury or person or property or death of any persons made by any person, group, or organization whether employed by Vendor or otherwise, or for breach of warranty by Vendor either expressed or implied.
